STATE OF OKLAHOMA, COUNTY OF CARTER:

I, Melissa G Handke, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Carter and in the State of Oklahoma, **CATLIN GAVITT** did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

COUNT 1: KEEPING PLACE / EQUIPMENT / FACILITY FOR COCKFIGHTING ~ a FELONY, on or about the 20th day of April, 2024, By knowingly having any person who keeps a pit or other place, or knowingly provides equipment or facilities to be used in permitting any cockfighting, contrary to the form of the statute in such cases made and provided and against the peace and dignity of the State of Oklahoma.

This crime is punishable by up to 10 years and or a fine of \$2,000 to \$ 25, 0000.

COUNT 2: OWN / POSSESS / KEEP / TRAIN BIRD FOR FIGHTING ~ a FELONY, on or about the 20th day of April, 2024, by owning, possessing, keeping or training any bird with the intent that such bird shall be engaged in cockfighting, contrary to the form of the statute in such cases made and provided and against the peace and dignity of the State of Oklahoma.

This crime is punishable by up to 10 years and or a fine of \$2,000 to \$25,000.
