On 04/20/2024 I Deputy Richard Reeder was dispatched to 5353 Santé Fe Rd. for a report of possible cock fighting.

I arrived at the address and observed approximately 5 vehicles on the property. On the property, I observed numerous fighting roosters. I did not see anybody at this time. Dispatch informed me that the fighting was taking place in the back of the property. Further North on the property on Santé Fe, there was a locked gate. There were several fresh tire tracks and huge ruts due to the rain. Deputy Lintner arrived on the scene with me. We then observed several vehicles coming out of the woods and heading back to the West. We then decided to drive further North on Santé Fe Rd. We then encountered several vehicles attempting to deconstruct a barbwire fence. I then stopped and the 3 males loaded back into their vehicles and drove back into the wooded area. We continued traveling North until we came to Memorial Rd. We turned back West and observed several vehicles driving through the pasture onto a lease road. We began attempting to stop the vehicles. With my lights and audible siren on I was attempting to get a white pickup truck to pull over (Texas NCP8666). The vehicle then took off traveling west at a high rate of speed.

I followed in behind and informed dispatch I was in pursuit. The vehicle continued west until reached U.S. Hwy 76, then proceeded south. I attempted to drive along the side of the vehicle. At that time the driver swerved over towards me. At the intersection of U.S. 70 and U.S. 76, the vehicle proceeded to travel west. At this time, the vehicle reduced its speed. The vehicle finally came to a just east of Hospital Rd. The pursuit lasted approximately 2.5 miles. I then conducted a felony stop. The vehicle was occupied a total of 4 times.

The driver was identified as Gustavo Barcenas JR 09/08/2005 the additional passengers were identified as follows. Gustavo Bacenas Sr. 11/08/1979, Alberto Barcenas 2/26/1984 and Josua Barcenas 07/02/1981. All occupants were detained in restraints. Upon searching the vehicle, 4 boxes containing fighting roosters were located in the back seat.

Oklahoma Highway Patrolman Mitchell arrived on the scene as backup.

A total of \$6578.00 was collected. All occupants were read their Miranda rights and asked about the cock fights. All 4 admitted to only being there to watch the fights.

The driver of the vehicle was placed under arrest for eluding. The vehicle was impounded.

The remaining occupants were issued citations and released from the scene. They were allowed to keep the animals that were located in the vehicle.

Gustavo Barcenas JR was transported and booked into the Carter County Detention Center without incident.

On 04/21/2024 at approximately 1129 hours I, Deputy Richard Reeder along with additional Carter County Deputies and members of the Wilson Police Department executed a search warrant at 5353 Santa Fe Rd Wilson Oklahoma.

The Carter County Sheriff's Office receives information on 04/20/2024 about possible cockfighting taking place at this address. Deputies arrived at the residence and observed several vehicles fleeing through the woods. Deputies were able to stop several of them and they admitted to watching the cock fights. A search warrant was issued on the evidence collected that day. (search warrant included with report).

The address is a huge property and two sites were hit simultaneously. Sgt Anderson took a team and proceeded to the main house. I took an additional team and preceded to the back of the property where the cock fighting had supposedly taken place.

My team and I made an entrance to the back side of the property and made our way through the wood line. We came to a huge metal barn. Once the scene was deemed safe and secure, we then proceeded to process it. The building was a metal structure and inside was an arena. On both sides of the arena were bleachers. The ground was covered with chicken feathers. There were trash cans filled with food and beverage cans. The food in the trash cans was not rotten. There was a small building just off of the main one. It was set up as a concession area. Inside there was a menu with food prices. There was a cash box that contained cash and coins. There was also a prescription pill bottle that belonged to Catlin Graviitt(a person who resides at the main house). There were multiple porta-potties on the scene. There were several chicken cages on the scene as well. Once that site was finished we then returned to the main house.

Sgt Anderson informed me there was no home. We then began processing the rest of the areas. Behind the main house, there are several small buildings and areas built to house roosters. The main areas have roosters that our in single cages(approximately 60). Inside the main house, Deputies located several Gaffs, Spurs, and Knives used in Cock Fighting. In the back Bedroom, two large Cock fighting trophies were located (commonly given out after a big event). Knives and Gaffs were located in a bedroom with the ID belonging to Catlin Gaff next to them. In a vehicle outside (JWT197) a light blue van (tag comes back to Darline Gravitt) a bag containing more Gaffs, Spurs, and knives was located. The vehicle was also outfitted to haul multiple Roosters. There were ice chests and folding chairs in the back seat. All evidence was logged and secured.

Deputies seized laptops, cell phones and tablets. (Believed to have communication for said cockfights). Deputies seized firearms from the residence. A complete list of evidence is attached to the report. A disk with photos is attached.

We will be requesting the following charges.
