## The problem:

- More tools are needed to dismantle hundreds of dogfighting rings and a network of cockfighters with 20 million fighting birds in the U.S.
- Ten of 15 outbreaks of virulent Newcastle Disease in the U.S. were tied to fighting birds smuggled from Mexico, resulting in billions of dollars in indemnity payments to farmers and billions more in costs to consumers in the form of higher egg and poultry prices.
- American cockfighters illegally ship tens of thousands of fighting birds to the Philippines, where \$13 billion was wagered in a single year in online cockfights ("e-sabong"). Hundreds of people were murdered there in cockfighting-related disputes and organized crime violence.

## The solution:

- Bans online gambling on dogfights and cockfights
- Enhances criminal forfeiture provisions
- Stops shipments of fighting roosters by the USPS
- Allows citizens to bring civil action against organized animal fighters to protect their property rights and to preserve their home values
